### Tom Harrington to Speak at Chamber Banquet

### *Chamber Bucks & Big Bucks Keeps Dollars in Sidney*

The Trade Promotion Committee completed its Big Bucks loan program on December 24th, and reports that 57 loans were made for a total of \$48,180. Providing the loans were Stockman Bank, First Bank, and Richland Federal Credit Union.

Another \$23,880 in Chamber bucks were purchased in 2008. In the month of December alone, \$19,685.00 were given as bonuses, Christmas gifts and donations.

These two programs resulted in \$72,060 in direct business to Chamber members in the past year.
